Project achievements and learnings

What activities did you undertake to complete the project? *

The following activities were undertaken to complete the project.

1. Inception meeting - five (5) inception meetings were held. The reason for these meetings was to inform project communities about the approval of the grant from the DAP and to recommit their responsibilities as agreed during the consultation period.
2. Procurement and construction - during the period under review, five modern latrines were constructed in Yarpuah, Gbarsue, Fassima, Gorlu, and Telemai. A dedication was done after the completion of every facility
3. Monitoring - routine monitoring was carried out throughout the project, along with the district authorities.
4. Training - Five training sessions were held with students, teachers, and community members about the usage of the restrooms. The training also stressed the needs and importance of good hygienic practices and the consequences that open defecation poses to human health.
5. An evaluation was done to ensure project success, impacts, and challenges.

What changes occurred as a result of these activities? *

The following changes were visibly seemed during and after the project, although more changes are expected.

1. Project beneficiaries are now practicing regular hands washing, especially after using the restrooms.
2. Open defecation on school campuses has completely stopped.
3. Student enrollment has increased with regular attendance due to the attraction of these modern latrine facilities;
4. The project has also given the community a sense of ownership over their health;
5. Each one teaches one model of health practices that calls for everyone talking to someone about health issues, especially washing hands, which was widely exchanged.
